



### **CLOSED FOR GOOD**

Although this scheme closed to new applicants in 2011, existing Tier 1 (General) visa holders have remained entitled to file applications to extend their conditions for up to three years under this category. However, as of 6 April 2015, the opportunity to gain an extension will be permanently removed.

In line with many other work-related visa categories, Tier 1 (General) visa holders are entitled to secure indefinite leave to remain (i.e. permanent residency) in the United Kingdom upon completion of five continuous years residence in the UK. The government has confirmed that the opportunity to secure permanent residency under this category will continue to remain open until 2018.

### PLAN AHEAD

Whilst the government's strategy for bringing a staged closure to this legacy scheme seems rational and all-inclusive, some Tier 1 (General) visa holders could still find themselves caught out by this change. Especially at risk are those migrants who intend to apply for permanent residence on or around April 2015 and therefore just before the door is closed on their ability to apply for an extension.

Securing permanent residence is not a foregone conclusion and can never be guaranteed. In order to qualify for indefinite leave to remain, there are many requirements that the applicant needs to meet. These include completing a Life in the UK Test ahead of filing the application, remaining within set limits on the number of days spent outside the United Kingdom and being free of criminal convictions.

Since failure to meet such requirements can lead to the residency application being refused, it is vital that migrants fully evaluate the likelihood of making a successful application. Should they believe their case for permanent residency to be weak, it may be wise to secure a three-year extension on their stay (ahead of the April 2015 deadline) as a precautionary measure.

The worst-case scenario would be for the indefinite leave to remain application to be refused leaving the applicant little or no time to file a secondary extension application prior to the cut-off date. This could mean the migrant is left with little option but to either apply to remain under a different immigration category or leave the United Kingdom altogether.

#### **DELAYING TACTIC**

Whether an applicant would be best served by submitting an extension application just prior to the April 2015 deadline depends on the individual's circumstances. However, deferring a permanent residency application can potentially enhance an applicant's chances of gaining a successful outcome. This tactic may be of particular benefit where the applicant holds a current or 'unspent' criminal conviction or where an excessive number of absences from the UK have been accumulated over the earlier qualifying period.

Applying for an interim Tier 1 (General) extension does not come cheap as the Home Office currently charges £1607 for an individual to apply by post. However, in order to avoid the doomsday scenario of both failing to secure permanent residency and being prevented from extending one's stay for a further period, it may just be seen as money well spent.

## **UKIMMIGRATION STATISTICS FOR 2013**

The Home Office's Immigration Statistics for 2013 provide figures on those subject to immigration control. All the data shown relates to the calendar year 2013.

### ADMISSIONS

111.1 million journeys were made to the UK in 2013. A large proportion (88%) were made by British, EEA or Swiss nationals who have rights of free movement and are not subject to immigration control.

VISITORS

1.9 million visitor visas were issued in 2013. This represents a 14% increase on the previous year. Increases were noted in a number of nationalities including Chinese, Russian and Indian.

WORK

There were 154.860 work-related visas issued in 2013. The increase was largely accounted for by higher numbers of Tier 2 skilled workers (+18% on previous year).

### STUDY

Study-related visas issued rose by 4% to 218,773 in 2013. A higher number of visas were issued to Chinese, Brazilian and Malaysian students although visas issued to Indian and Pakistani nationals fell dramatically. With stricter controls applied to the student immigration route, a significant drop (34%) was noticed in student visas issued specifically in the further education sector.

### STAYING IN THE UK

## NEW IMMIGRATION BILL BECOMES LAW

With the new Immigration Bill finally gaining Royal Assent, the path is now clear for the government to introduce a series of reforms to the UK's immigration system which intend to limit the factors attracting illegal immigrants to the UK and to make it easier to remove those with no right to be in the UK.



The main provisions of the Act include:

- reducing the number of immigration decisions which can be appealed from 17 to four
- allowing some harmful individuals to be returned to their home country before appeals are heard if there is no risk of serious irreversible harm
- ensuring courts have regard to Parliament's view of what public interest requires when considering the European Convention of Human Rights, article 8 in immigration cases—the right to a family life is not to be considered absolute and unqualified
- clamping down on sham marriages and civil partnerships being used as a way of trying to gain an immigration advantage
- preventing those with no right to live in the UK from accessing private rented housing by requiring private landlords to check the immigration status of tenants

- introducing a requirement for certain migrants to make a financial contribution to the National Health Service – this will apply to temporary migrants with a time-limited immigration status
- allowing the Home Secretary to deprive a naturalised individual of their British Citizenship if his/her actions have been seriously prejudicial to the interests of the UK, and the Home Secretary has reasonable grounds for believing the person is able to become a national of another country

The reforms are likely to be introduced swiftly. Immigration and Security Minister, James Brokenshire, referred to the Act as a landmark piece of legislation and said: 'We are already planning its implementation and will ensure these measures are introduced quickly and effectively.'

## MAINTENANCE FUND ADJUSTMENT



The maintenance thresholds for Points-Based System Migrants and their dependants are to be updated and increased from 1 July 2014. The changes in the level of maintenance funds required by student, worker and family migrants are in line with the costs of living in the UK. By way of example, the maintenance requirement for a Tier 2 migrant has been increased to £945 (from £900) and to £630 (from £600) for accompanying dependants.

# PASSPORT RETURN SERVICE EXTENDED

Applicants applying for indefinite leave to remain (ILR) under the Tier 2 points-based system in the UK will receive their passports and their Biometric Residence Permits (BRP) back before a decision has been made on their application under a new service which launched on 6 May 2014.

The passport return service, which was previously only available to applicants in the Tier 2 Intra Company Transfer (ICT) route, will allow Tier 2 (ILR) applicants to have their passport and BRP returned within 7 to 10 days of their application being created for processing on the Home Office system.

### **NEW HONG KONG VISA CENTRE**

A new Hong Kong Visa Application Centre opened last month with the promise to provide greater convenience and choice to customers through extended opening hours and a range of premium services. The new office was officially opened by Foreign Office Minister, Mark Simmonds, and is located in Causeway Bay. Business is set to be brisk.

Over 10,500 visas to enter the United Kingdom were issued in Hong Kong last year and this number is set to rise. The increase in applications filed will be partly because Hong Kong formally joined the Youth Mobility Scheme from January 2014. This reciprocal scheme will allow 1000 HKSAR passport holders aged between 18 and 30 to be granted permission to live, work and/or study for up to two years in the UK.



### ENGLISH LANGUAGE TEST CHANGE



The Home Office has decided to end its relationship with ETS Secure Language Tests (SELT) with immediate effect.

Migrants will no longer be able to present an English language test issued by SELT in support of an immigration

application and are advised to take an additional test via an alternative test provider (such as Pearson) ahead of filing their visa application.



# FOCUS

This month's focus falls on the work carried out within the UK visa application centres (VAC) run on behalf of UK Visas and Immigration.

### What work is carried out by the VACs?

Visa application centres collect information from those migrants applying for a UK visa. The information collected includes the application form, passport, supporting documents and biometric data. This documentation is then used by the UK Visas and Immigration staff to assess and decide upon the visa application. Applications for a visa can be submitted up to three months before the proposed date of travel to the UK.



### How is biometric data collected?

During the visit to the VAC, applicants will be required to provide biometric information in support of their application submission. This includes a digital finger scan (all 10 digits) and a digital photograph. The finger scan procedure uses an electronic scanner. Fingertips must be free from any forms of decoration (for example, henna), cuts, abrasions or other markings as these may prevent the VAC from collecting a clear scan.

### Do children follow the same procedure?

Every applicant who is submitting a visa application must attend the visa application centre in person. Children less than five years old need to attend, but are not required to provide their biometric data. Children less than 16 years old need to be accompanied by an adult at all times.

### Are applicants interviewed?

If you are a student applying under the points based system (Tier 4), you will need to sit a short interview in the visa application centre. For non-student applications, UK Visas and Immigration will conduct interviews if deemed necessary during the processing of your application.

### How long are processing times?

This depends on the category of visa application, but UK Visas and Immigration aims to return 90% of non-settlement visa applications within 15 working days. However, individual circumstances can mean processing times may vary and result in longer decision times. The processing time for a settlement application is significantly higher with 95% of cases resolved within 12 weeks.

### Is there a way to expedite the process?

The Super Priority Visa service is an optional service offered by UK Visas and Immigration and costs £600 (local currency equivalent at latest consular exchange rate) in addition to the standard visa fee. A target has been set to

process super priority visa applications on the same day that they are received. At present, the service is only open to those applicants applying for a visit visa or to employees of companies that are members of the Business Express Programme.

### How are documents returned to the applicant?

Arrangements can be made with the visa application centre for the documents to be either couriered back or collected in person.

## What security procedures are held in place at the VACs?

For security reasons, certain items will not be permitted inside the visa application centre. These include:

- All battery operated or electronic items such as cameras, audio/video cassettes, compact discs, MP3s, laptops, or portable music players.
- All bags such as travel bags, backpacks, briefcases, suitcases, leather, jute or cloth bags and zip folders.

Only a plastic bag containing the application and related papers will be permitted.


